For Athletes who currently represent Wales and/or Great Britain

Criteria and Guidance Notes

Eligibility

1. Applicant must reside in Carmarthenshire, OR
2. Applicant attend's a school in Carmarthenshire, OR
3. Applicant is a member of a Sports Club in Carmarthenshire, providing financial assistance is not available from applicant's County of residence AND
4. Applicant must participate in one of the eligible sports (please see attached) AND
5. Applications must be received by Carmarthenshire County Council prior to the athlete attending the event/competition

Only one funding application can be submitted within a 12-month period.

Financial assistance can be sort for:

- Athletes who incur travel costs while competing at national or international non-professional level.
- Travel expenses and/or purchase of equipment, when selected to attend the necessary specialist squad training sessions to prepare the athlete for national/international representation.

- Carmarthenshire County Council also operates a gold card scheme whereby athletes who represent Wales and/or Great Britain can apply for free use of the Authority's relevant Leisure facilities.
- A grant will only be payable to athletes that submit the application form prior to attending the competition for which the grant is being sought. All applications will be date stamped when received by Carmarthenshire County Council and this will be the official submission date.
- The relevant National Governing Body may be consulted
